




#### Mike O'Neill says... YOU GOTTA ASK!

It is a memoriam to honor the passing of two great airmen, the heroes of UA232 in Sioux City, Iowa: Captain Al Haines and Captain Denny Fitch.

I was the IIC along with Bob Benzon, Frank Hilldrup was the Structures Group Chair, Greg Phillips was Systems, Wisniak along with Jack Young were the Powerplants Chair and Jim Wildey was the lead in the Materials Lab. Nora Marshall was in for Survival Factors. She dealt with 186 survivors and 110 fatally injured. Lots of other staff made up a really great NTSB team for this one. We will all remember the two guys up there in the cockpit.

#### **IN MEMORIAM**

Thank you for the obituary of Alfred C. Haynes (Sept 2-15, p.9), the pilot who guided United Airlines (UAL) Flight 232 to a crash landing at Sioux City, Iowa, following an uncontained engine failure that destroyed all three hydraulic flight control systems.

Capt. Haynes was aided during that accident scenario by a remarkable DC-10 simulator instructor at the UAL Training Center in Denver, Capt. Denny Fitch, who was on the flight. Fitch came forward from the cabin and introduced Haynes to the concept of controlling the flightpath by way of the remaining wingmounted engines. Haynes demonstrated the utmost in cockpit resource management, and Fitch manipulated the power levers to avoid a total loss of control during a descent and approach. Both pilots cooperated to maneuver the aircraft to a controlled crash landing at the airport. Although Fitch passed away earlier, he deserves equal mention with Haynes for their extraordinary airmanship that allowed 184 of the 296 passengers to survive. May both airmen now rest in peace.



Mrs. Mittleman, a resident of Fulton, Md., was born Vivian Wiesner in Brooklyn, N.Y. She settled in the Washington area in 1987 and was a lawyer with the Federal Aviation Administration, the National Transportation Safety Board and the U.S. Postal Service before joining the Social Security Administration.
